In order to be eligible for reimbursement under the 3P program, an application along with the three (3) documented quotes signed by both the property owner(s) and the contractor for the eligible works must be submitted to the City and approved PRIOR to the provision of any grants. Property owners shall not assume they are approved for the grant prior to confirmation from the City. If approved, the amount eligible for the grant will be stated on the confirmation letter.							
	3. It is the property owner's responsibility to have all improvements with the exception of downspout disconnections completed by:							
	a. A plumbing contractor licensed to work within the City of Hamilton, meaning that the contractor has a valid City of Hamilton Master Plumber license and a valid City of Hamilton Plumbing Contractor license, or							
	<ul> <li>A licensed Drain Repair Contractor, meaning that the contractor has both a Drain Installer Master's License and a Drain Repair Contractor's License.</li> </ul>							
	4. It is the property owner's responsibility to pay the contractor(s) for any and all works completed that are not covered by the 3P Program. In order for the grant to be issued, the homeowner must provide proof that the contractor has been paid in full.							
	5. All work requiring a building permit must pass inspection by the City.							
(	6. Any amount reimbursed by the City will be deducted from eligible grant money available under the 3P Program for this property. The maximum grant is \$2,000, including any previous payments made
